## What is a prepaid funeral trust?

A prepaid funeral trust allows you to set money aside now to pay for your funeral expenses when you're gone. The money is held in a specially created trust and when the time comes to use it, it is available immediately.

## Why do I need a prepaid funeral trust?

A prepaid funeral trust is a great way to prepare for the future and make things easier on your loved ones by reducing financial stress during a difficult time. Funeral costs generally start at about \$4,000 and can go up to \$10,000 or more depending on your wishes and your budget. With a prepaid funeral trust, you can take comfort knowing that your funeral expenses are taken care of.

*(This includes funeral direction and registration of death, costs of a casket and hearse, cremation or burial, headstone or plaque, flowers, a minister or celebrant, newspaper notices and the reception.)*

The money held in a prepaid funeral trust is locked away and can't be used for anything else.

## How does a prepaid funeral trust work?

When you set up a prepaid funeral trust, a funeral trust deed is drawn up to record your wishes. You can review and update your wishes at any time - it's also a good idea to capture these in your will too.

*\*Closure and withdrawal fees are only subject to permanent emigration or transferring Funeral Trust to another provider.*
