Building Maintenance Works

1.0 Background

The Fiji Public Trustee Corporation Pte Ltd (FPTCL) is a public enterprise that provides estates and trust administration services, estate planning and other legal services to the people of Fiji.

2.0 Objective

To engage a reputed registered contractor to carry out building maintenance work.

3.0 Scope of Works

The following works are required: -

- (a) Check the roof, ceiling and walls to identify the source and location of the rainwater leaks.
- (b) Repair the damaged area to stop rainwater leaks.
- (c) Painting of damaged roof, walls and ceiling.
- (d) Repair and seal birds access area.
- (e) Repair all water leaking from aluminum windows/window seal leakage.
- (f) Fill all gaps between aluminum window frames and concrete.
- (g) Water proofing of window frames - outside and inside.
- (h) Check and repair ceiling leakage and gutter.
- (i) Outside boardroom passage ceiling leakage.
- (j) Customer Service area – wall crack, leakage inside and outside.
- (k) Check server room ceiling leakage and repair.
- (l) Check and repair ridge cap.
- (m) Manager Legal's room leakage and windows to be fixed.

(n) Back door car park entrance ceiling leakage and the stairway leakage.

4.0 Timeline

FPTCL anticipates the selected bidder to complete the above scope of works within 1 month of initiating.
